What is Authority® 480 herbicide?

Authority[®] 480 herbicide is a powerful, flexible pre-emergent Group 14 herbicide that provides extended activity on challenging broadleaf weeds in soybeans and many other crops. Authority[®] 480 herbicide can be applied alone or can be tank-mixed with glyphosate and other registered partners. Its convenient liquid formulation ensures ease of use and mixing.

How does Authority[®] 480 herbicide help my farm business?

- Ideal for IP soybeans. Authority[®] 480 herbicide controls many of the most troublesome weeds you face. These include lamb's-quarters, pigweeds, Eastern black nightshade and common waterhemp.
- Works well with herbicide-resistant soybeans. Authority[®] 480 herbicide can be applied pre-plant or pre-emergence with glyphosate to facilitate timelier post-emergence applications in glyphosate tolerant soybeans. Authority[®] 480 herbicide will alleviate pressure from the first flush of weeds and help make your post-emergent weed control more effective.
- **Tough on weeds, gentle on your crop.** Its track record in both Canada and the U.S. indicates that Authority[®] 480 herbicide combines excellent weed control and crop safety.
- Effective against resistant weeds. As a Group 14, Authority[®] 480 herbicide controls a wide range of broadleaf weeds, including those resistant to Groups 9, 5 and 2.
- **Tank-mix flexibility.** In addition to glyphosate, Authority[®] 480 herbicide has multiple options for tank-mixing. It may be tank-mixed with other broadleaf herbicides, such as metribuzin or imazethapyr, to supplement broadleaf control. To control grass weeds, tank-mix with a grass herbicide such as Focus[®], Boundary[®] LQD, Conquest[®] LQ or Frontier[®] Max.

What rate should I use and when do I apply?

Authority[®] 480 herbicide is applied at a rate of 32 acres per jug (118 mL/ac). A low rate of 43 acres per jug (88 mL/ac) is available for control of kochia. Apply pre-plant or post-seed (up to 3 days after seeding).

Rates for tank-mixes with Authority[®] 480 herbicide are as follows:

How does Authority[®] 480 herbicide fit into my crop rotation?

Soybeans can be planted any time following an application of Authority[®] 480 herbicide. For other crops, planting guidelines are as follows.
