Re: **Emergency registration of Fullback 125 SC Fungicide (Reg. No. 31679), containing flutriafol, for the control of halo blight (*Diaporthe humulicola*) on hops in Québec, Ontario, Manitoba, Saskatchewan, and Prince Edward Island from June 1, 2023 to May 31, 2024**

Your application to amend the registration of Fullback 125 SC Fungicide for the emergency control of a new emerging disease, diaporthe leaf spot (halo blight) on hops in Québec, Ontario, Saskatchewan, Manitoba, and Prince Edward Island has been granted. Pursuant to section 18 of the *Pest Control Product Regulations* the amendment is granted for a validity period beginning June 1, 2023 and ending May 31, 2024, subject to the following conditions:

- Label changes must be made according to the attached annotated supplemental label.

Ministère de l'Agriculture, des Pêcheries et de l'Alimentation du Québec must inform FMC of Canada Limited should they become aware of any incident that occurs as a result of this emergency use. For information on the Incident Reporting Program, please contact PMRA-Incident-ARLA@hc-sc.gc.ca.

Emergency registration is not intended to serve as a regulatory option in ongoing pest problems or where there is an ongoing need for a registered product to fill a void where no registered product is available. MAPAQ is encouraged to take a leadership role with the hops industry and the registrant to ensure that an application for regular registration of Fullback 125 SC Fungicide is submitted to the PMRA in the near future.
