As an early post or topdress application, Ally® Extra SG herbicide with TotalSol® soluble granules provides residual control from the toughest broadleaf weeds, allowing for a cleaner grain crop to receive ample nutrients without competing weeds.

Gain even greater application flexibility with Ally Extra SG herbicide. Apply in the spring, summer or fall. You can choose the timing of your fertilizer application and decide when to treat weed problems, depending on your workload.

Quick Facts:

- Flexibility to apply with topdress fertilizer for clean fields to get wheat crops off to a healthy start.

Application Timing and Information:

- Apply in the spring, summer or fall when the majority of weeds have emerged and are actively growing.
- Apply to wheat and barley as early as second leaf stage until before the flag leaf is visible except durum wheat and wampum varieties of spring wheat.
- Tank mix with MCP ester or dicamba.
- Dissolve in water prior to adding MCP ester and add the surfactant last.

Product Use Rate:

Apply 0.3–0.5 oz./A.

Restrictions:

Do not apply more than 0.5 oz./A per year.
