PRODUCT DESCRIPTION:

CS-100-12 Herbicide is recommended for selective post-emergent control or suppression of broadleaf weeds and grasses in wheat (spring, durum and winter) not underseeded to legumes or grasses. CS-100-12 Herbicide is to be mixed with water and a recommended adjuvant and applied as a uniform broadcast spray. Recommended adjuvants include: AGRAL* 90, Liberate* Adjuvant, Ag-Surf* II, HiActivate* Non-ionic Liquid Spreader/Activator, Super Spreader Adjuvant, Enhance*, Pro-Surf* II and Sentry. It is non-corrosive, non-flammable, non-volatile and does not freeze.

Apply CS-100-12 Herbicide early post-emergence, to the main flush of actively growing weeds. Warm, moist growing conditions promote active weed growth and enhance the activity of CS-100-12 Herbicide by allowing maximum foliar uptake and contact activity. Weeds hardened off by cold weather or drought stress may not be adequately controlled or suppressed and regrowth may occur. For best results, ensure thorough spray coverage of target weeds. See "DIRECTIONS FOR USE" section of this label for complete use details.

CS-100-12 Herbicide stops growth of susceptible weeds rapidly. However, typical symptoms (discolouration) of dying weeds may not be noticeable for 1 to 3 weeks after application, depending upon growing conditions and weed susceptibility. Degree of control and duration of effect are dependent on weed sensitivity, weed size, crop competition, growing conditions at and following treatment, and spray coverage.

IMPORTANT INFORMATION: READ BEFORE USING

Injury to or loss of desirable trees or vegetation may result from failure to observe the following:

- Do not apply, drain or flush equipment on or near desirable trees or other plants, or on areas where their roots may extend, or in locations where the chemical may be washed or moved into contact with their roots.

The following crops can be seeded 11 months after an application of CS-100-12 Herbicide: barley, brown mustard, canola, dry bean (of the species *Phaseolus vulgaris*), flax, canola quality Brassica juncea, lentils, oats, field peas, chickpea, spring wheat, soybean and yellow mustard or fields can be summerfallowed. The following crops can be seeded 10 months after an application of CS-100-12 Herbicide: sunflower and potatoes.

GRAZING/HARVEST RESTRICTIONS:

Livestock may be grazed on treated crops 7 days following application. Do not harvest the treated crop within 60 days after application.

VARIETY RESTRICTIONS:

Limit use of CS-100-12 Herbicide to currently licensed varieties of wheat (spring, durum and winter). Consult FMC Corporation prior to use on unlicensed varieties for crop tolerance information.

RAINFASTNESS INFORMATION:

If foliage is wet at the time of application control may be decreased. Applications of CS-100-12 Herbicide are rainfast within 2 hours after application.

APPLICATION INFORMATION:

APPLICATION PRECAUTIONS:

- Do not apply to irrigated land where tail water will be used to irrigate cropland.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests.
- Overspray or drift to important wildlife habitats such as shelterbelts, wetlands, sloughs

Flat fan nozzles are recommended (minimum 55 litres spray volume per hectare). Use 50 mesh or larger filter screens (metal or nylon). A spray pressure of 210-275 kPa is recommended. Avoid overlapping and shut off spray boom while starting, turning, slowing or stopping to prevent crop injury from over application.

AERIAL APPLICATION:

Apply only by fixed-wing or rotary aircraft equipment, which has been functionally and operationally calibrated for the atmospheric conditions of the area and the application rates and conditions of this label. CS-100-12 HERBICIDE

LOCATION: Prairie Provinces and Interior of of British Columbia

CROP(S): Spring wheat, durum wheat and winter wheat

TIMING: Apply from the 3-leaf stage to just before the flag leaf (shot blade) stage of the spring wheat (including durum), prior to head emergence, but before the crop canopy will prevent thorough coverage of target weeds. Apply to winter wheat in the spring, when winter wheat is in the 2-7 leaf, 4 tiller stage. Do not apply after head has emerged. For best results, apply to young, actively growing weeds: broadleaf weeds that are less than 10 cm in height or diameter (unless otherwise specified) and grass weeds that are within the specified growth stages. Thorough coverage of target weeds is essential. WINTER WHEAT (SPRING APPLICATION) FOR DOWNY BROME

CS-100-12 Herbicide applied as a spring application will provide suppression of downy brome in winter wheat. Apply at a rate of 100 g per hectare. Add BASF Assist Oil Concentrate at 0.8% v/v (0.8 L/100 L of spray mixture) or Merge* Adjuvant at 0.5% v/v (0.5 L/100 L of spray mixture; spring application only). Apply using equipment that will assure uniform coverage. In addition to suppression of downy brome when applied in the spring, this tankmix also control/suppress weeds listed.

<u>Tankmixes</u>: In some cases, tank mixing a pest control product with another pest control product or a fertilizer can result in biological effects that could include, but are not limited to: reduced pest efficacy or increased host crop injury. The user should contact FMC Corporation at 1-833-362-7722 for information before mixing any pesticide or fertilizer that is not specifically recommended on this label. The user assumes the risk of losses that result from the use of tank mixes that do not appear on this label or that are not specifically recommended by FMC Corporation.

When applied as a tank-mix combination, read and observe all label directions, including rates, restrictions, and grazing limitations for each product used in the tank-mix. Follow the more stringent label precautionary measures for mixing, loading and applying stated on both product labels.

MIXING INFORMATION:

MIXING PRECAUTIONS:

If the sprayer has been left standing for a period of time agitate thoroughly to re-suspend the tank mix partner before resuming spraying. Spray preparation should be used within 24 hours or product degradation may occur.

MIXING DIRECTIONS:

Select a spray volume that will ensure thorough coverage and a uniform spray pattern. Use a minimum of 55 L of spray volume per hectare for ground application, and between 30 to 50 L of spray volume per hectare for aerial application. If tank mixing with other herbicides, always consult the label of the tank mix partner(s) for minimum spray volume requirements and apply the tank mixture using a water volume recommended for all products.

- 1. Always start with a clean and empty sprayer tank.
- 2. Fill the tank to 2/3 full of clean water.
- 3. With the agitator running, add the required amount of CS-100-12 Herbicide. Continue to agitate for a minimum of 5 minutes to ensure that CS-100-12 Herbicide is **completely** dispersed.
- 4. Make sure there are no un-dissolved granules, and then add the rest of the water.
- 5. Add the non-ionic surfactant at 0.25% v/v (0.25 L per 100 L of spray solution). If an antifoam agent is required, add last.

6. For repeat tank loads, reduce the material remaining in the tank to 10% of the original volume **or less** before proceeding with step 1, because remaining chemicals may prevent CS-100-12 Herbicide granules from completely dissolving or dispersing.

SPECIAL MIXING INSTRUCTIONS FOR CHEMICAL HANDLERS

- 1. Ensure the chemical handler is clean (rinsed with ammonia).
- 2. For best results, add CS-100-12 Herbicide to the top of the sprayer tank.
- If a chemical handler is used, make sure that all of the granules of CS-100-12 Herbicide are completely dispersed and injected into the main tank with agitation before adding other chemicals.
- 4. Low water volumes in some chemical handlers can cause the water to become saturated with CS-100-12 Herbicide, leaving un-dissolved granules. In that case, rinse the chemical handler with clean water before adding any other chemical.
- 5. Always dissolve the CS-100-12 Herbicide granules with agitation in the main tank before adding a tank mix partner.

NOTE: Follow the clean-out procedure recommended for sprayer tanks for the chemical handler.

EQUIPMENT CLEANING INFORMATION:

CLEANING PRECAUTIONS:

CAUTION: Do not use ammonia with chlorine bleach. Using ammonia with chlorine bleach will release a gas with a musty chlorine odour, which may cause eye, nose, throat, and lung irritation. Do not clean equipment in an enclosed area.

DO NOT CLEAN SPRAYER NEAR WELL OR WATER SOURCE OR NEAR TO DESIRABLE VEGETATION.

CLEANING INSTRUCTIONS:

To avoid injury to desirable plants, thoroughly clean equipment used to apply this product before re-use or using it to apply other chemicals.

- 1. Immediately after spraying, completely drain the sprayer tank. Any contamination on the outside of the spraying equipment should be removed by washing with clean water.
- 2. First rinse:
- Spray the inside of tank with clean water and fill the sprayer with at least one tenth of the spray tank volume.
- Agitate and circulate for 15 minutes, and flush through booms and hoses.
- Remove end caps or open ball valves on the ends of each boom section, and flush solution through the boom ends to ensure there is no spray solution trapped between the boom end and the nozzles.
- Drain tank completely.
- 3. Second rinse:

- · Fill the tank with clean water.
- Add All Clear Spray Tank Decontaminator, or Clean-Out Spray Tank Cleaner, or 1 L of household ammonia (containing a minimum of 3% ammonia) per 100 L of water, or similar tank cleaning agent as per manufacturer's recommendations while willing the tank with clean water.
- Agitate and then flush the boom and hoses with the cleaning solution. Top up with water
 making sure the tank is completely full. Allow to stand for 15 minutes with agitation. Flush
 the solution out of the spray tank through the spray booms. Remove end caps or open
 ball valves on the ends of each boom section, and flush solution through the boom ends
 to ensure there is no spray solution trapped between the boom end and the nozzles.
- If possible, let the solution stand in the sprayer tank and booms for an extended period of time, overnight if possible.
- After flushing the boom and hoses, drain tank completely.
- Remove nozzles and screens and clean separately with a cleaning agent or an ammonia solution (100 mL in 10 L water).
- 4. Third rinse:
- Rinse the tank with clean water and flush through the boom and hoses using at least one tenth of the spray tank volume.
- Remove end caps or open ball valves on the ends of each boom section, and flush solution through the boom ends to ensure there is no spray solution trapped between the boom end and the nozzles.
- Drain tank completely.

RESISTANCE-MANAGEMENT RECOMMENDATIONS:

For resistance management, CS-100-12 Herbicide is a Group 2 herbicide. Any weed population may contain or develop plants naturally resistant to CS-100-12 Herbicide and other Group 2 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Other resistance mechanisms that are not linked to site of action, but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay herbicide resistance:

- Where possible, rotate the use of CS-100-12 Herbicide or other Group 2 herbicides within a growing season (sequence) or among growing seasons with different herbicide groups that control the same weeds in a field.
- Use tank mixtures with herbicides from a different group when such use is permitted. To
 delay resistance, the less resistance-prone partner should control the target weed(s) as
 effectively as the more resistance-prone partner.
- Herbicide use should be based on an integrated weed management program that
 includes scouting, historical information related to herbicide use and crop rotation, and
 considers tillage (or other mechanical control methods), cultural (for example, higher crop
 seeding rates; precision fertilizer application method and timing to favour the crop and not
 the weeds), biological (weed-competitive crops or varieties) and other management
 practices.
- Monitor weed populations after herbicide application for signs of resistance development (for example, only one weed species on the herbicide label not controlled). If resistance is suspected, prevent weed seed production in the affected area if possible by an alternative herbicide from a different group. Prevent movement of resistant weed seeds to other fields by cleaning harvesting and tillage equipment when moving between fields, and planting clean seed.
- Have suspected resistant weed seeds tested by a qualified laboratory to confirm resistance and identify alternative herbicide options.

- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or integrated weed-management recommendations for specific crops and weed biotypes.

STORAGE:

Store product in original container only, away from other pesticides, fertilizer, food or feed. Not for use or storage in or around the home. Keep container closed.

DISPOSAL:

Recyclable Containers: Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

- 1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
- 2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

Refillable Containers:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not reuse this container for any other purpose.

Returnable Containers:

Do not reuse this container for any other purpose. For disposal, this empty container may be returned to the point of purchase (distributor/dealer).

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for cleanup of spills.

NOTICE TO USER:
