

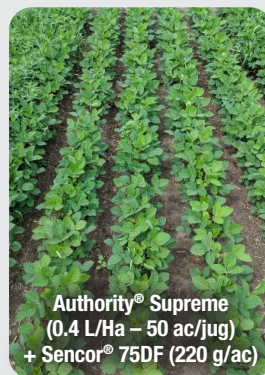

## PROGRAM RULES AND CONDITIONS

1. Growers who purchase a minimum of one unit (33 acres/jug rate) of FMC Authority<sup>®</sup> Supreme herbicide and purchase the corresponding eligible Bayer products Sencor<sup>®</sup> 480F herbicide or Sencor<sup>®</sup> 75DF herbicide between November 1st, 2020 and October 31st, 2021 will qualify for the rebate outlined above.
2. Only eligible products listed in the table above are entitled for the offer. Products other than those outlined above do not qualify. Brands or formulations of metribuzin other than Bayer Sencor<sup>®</sup> 480F herbicide or Bayer Sencor<sup>®</sup> 75DF herbicide do not qualify for this offer.
3. For fulfillment, matching acre purchase of Sencor<sup>®</sup> 480F herbicide (or Sencor<sup>®</sup> 75DF herbicide) is required to be from the same retailer as the eligible Authority<sup>®</sup> Supreme herbicide.
4. Eligible Growers and Retailers are only in the Provinces of Ontario, Quebec and the Maritimes.
5. Rebates will not be paid on sales of FMC Canada products to: (i) other retailers or otherwise not to growers, or (ii) growers outside of Ontario, Quebec, New Brunswick, Nova Scotia, Newfoundland or Prince Edward Island, or (iii) to growers more than one hundred and sixty (160) kilometers from the applicable retail sales location with respect to the sale.
6. Authority<sup>®</sup> Supreme herbicide sales to be calculated based on the application rate listed in the above table (33 acres per 8 litre jug). This translates to a reward potential for matching acres of \$165 per unit of Authority<sup>®</sup> Supreme herbicide.
7. Bayer Sencor<sup>®</sup> 480F herbicide (or Bayer Sencor<sup>®</sup> 75DF herbicide) matching acre sales to be calculated based the application rate outlined in the above table (14.5 acres per 5 litre jug of Sencor<sup>®</sup> 480F or 11 acres per 2.5 kg jug of Sencor<sup>®</sup> 75DF).
8. Either or both of the Sencor<sup>®</sup> 480F or the Sencor<sup>®</sup> 75DF herbicide brands may be applied towards a Grower's matching acre program calculation, however matching acre purchases count only once in the calculations.
9. FMC Canada reserves the right to audit all sales of FMC Canada products by the Retailer to growers in order to confirm the accuracy of the sales and to adjust if necessary, any affected rebates retroactively.
10. Rebate will be calculated based on data submitted as specified by FMC Canada. Rebates are paid on net OTG sales by customers, less product returns.
11. Rebate will only be paid once FMC Canada has received grower transactional sales data of FMC Authority<sup>®</sup> Supreme herbicide from the Retailer. Payment of this incentive will be paid by FMC by January 2022. All payments will be made only to the Retailer named in the agreement and not to specific individuals. Retailer is responsible for rebate payment disbursement to qualified growers.
12. Information and Data Usage: By enrolling in the 2021 FMC Authority<sup>®</sup> Supreme + Sencor<sup>®</sup> Grower Offer, the grower acknowledges that their retailer(s) will submit purchase information, which may include personally identifiable information such as contact information and all necessary purchase data from the Grower and the Retailer, on their behalf to FMC Company and authorizes FMC, their affiliates and any third parties designated by FMC to use such information provided for the following purposes:
  - i. Calculation, administration and carry through of this program. Certain of these affiliates or third parties may be located in countries outside of Canada.
