2022 TERMS & CONDITIONS

1. **Offer Period:** The 2022 FMC CashBack (the “Offer”) is administered by FMC of Canada Limited (“FMC”) and begins on November 1, 2021 and concludes on October 31, 2022.
2. **Eligibility:** The offer is open to Canadian Growers who reside in British Columbia, Alberta, Saskatchewan or Manitoba and are the owner, operator or designated representative of a farm.
3. **Pre-Enrollment:** Growers who participated in and received a rebate payment from FMC from the 2021 FMC CashBack program will automatically be enrolled for the 2022 Offer. This enrollment will remain in effect for all subsequent years unless FMC receives notification in written form from the Grower explicitly stating that they no longer wish to participate in the current or subsequent Offers.
4. **Enrollment:** Growers who meet the qualifying purchase criteria for the 2021 FMC CashBack Program will automatically be enrolled in the 2022 program. FMC must receive written notice from the Grower if they wish to cease membership in the FMC Grower program.
 - (a) Pre-enrolled Growers who qualified for rebates in the 2021 FMC CashBack Offer may register at fmccashback.ca to choose one of three thank you gifts: the 22Fresh Hoody (valued at \$100 CAD) or a Stanley tool kit (valued at \$110 CAD) or request a donation be made on their behalf to one of the pre-selected charitable organizations by FMC. Pre-enrolled Growers will receive their thank you gift before June 30, 2022 providing that all the terms and conditions are fulfilled on or before February 28, 2022. Due to global supply issues and concerns, these thank you gifts may not arrive until after the dates above.
 - (b) Growers must fill out the mandatory sections of the fmccashback.ca portal to receive their free thank you gift.
 - (c) Growers can only receive one free thank you gift per farming operation.
 - (d) Growers who did not qualify for a rebate in the 2021 FMC CashBack program (not pre-enrolled) must qualify for the 2022 Offer to be eligible to receive a free thank you gift.

Growers who qualify for a rebate in the 2022 Offer but were not pre-enrolled and fulfill all the terms and conditions of this program will receive their free thank you gift by December 31, 2022, while quantities last.
5. **Qualification:** Purchase a minimum of \$5,000 of eligible FMC products between November 1, 2021 and October 31, 2022.
6. **Purchase Segments:** Rebates are paid as per the following logic:
 - (a) Total dollars purchased of FMC products at 2022 Suggested Retail Price (MSRP) pre-qualify a Grower for rebates corresponding to the segment of products and their total purchase percentages as per the chart below:

- (b) No minimum unit or acre purchase is required in any segment to receive a rebate on that segment.
- (c) No matching acres are required between the Pre Herbicide and Post Herbicide segments.

(d) Purchases from the Purchase Level Builders Segment count towards the overall dollars purchased and can move the Grower up in the dollar categories, however, the products within this segment are not eligible for rebates.

There are 3 product segments (See below for products in each segment).

i. Products in the **“Pre Herbicides”** Segment Include (products eligible for rebate):

- Authority® 480, Authority® Supreme, Command® 360 ME, Command® Charge, Focus®, Intruvix™ herbicide, SZ-75 herbicide, SZ-0050 herbicide
- Virtual purchases of Command® Charge herbicide and Intruvix™ herbicide will also be eligible for rebates under the “Pre Herbicides” segment
 - A virtual purchase of Command® Charge herbicide would consist of one 5.4L jug of Command® 360 ME herbicide purchased in conjunction with one 1.2L of Aim® EC herbicide or equivalent amounts of other Aim® EC herbicide SKUs
 - A virtual purchase of Command® Charge herbicide would also consist of Command® 360 ME herbicide purchased in conjunction with the following amount of CF-18 Herbicide from PrecisionPac®:

- A virtual purchase of Intruvix™ would consist of one 1.2L of Aim® EC with 80 acres of Express® FX and/or PrecisionPac® DB-878 herbicides
- A virtual purchase of Intruvix™ would consist of Express® FX and/or PrecisionPac® DB-878 herbicides purchased in conjunction with the following amount of CF-09 Herbicide:

- For complete details of the calculations for virtual Command® Charge and Intruvix™ see the Ace Resistant Weeds Program Terms and Conditions
- Growers will not be able to receive ACE Resistance Weeds Program rebates on Command® 360 ME herbicide in addition to 2022 FMC CashBack rebates. The purchase acres of Command® 360 ME herbicide will be matched with an Aim® EC herbicide purchase in the ACE Resistance Weeds offer first. Any Command® 360 ME herbicide unmatched acres will then be eligible for a rebate in the 2022 FMC CashBack Program.

ii. Products in the **“Post Herbicides”** Segment Include (products eligible for rebate):

- Ally® Toss-N-Go®, Barricade® II, Predicade®, Refine® M, Refine® SG, Travallas®, PrecisionPac® herbicides (PP-2525, PP-23235, PP-3317, DB-8454, Triton® C, Ally® High, Ally® Low, CS-75-2525, CS-100-2525, CS-75-23235, CS-100-23235, CS-100-12, CS-75-12, CS-100-50, CS-75-50, Perimeter® II*)

*Perimeter® II Herbicide must always be matched to total acres of broadleaf purchase. Perimeter® II Herbicide rebate dollars will be calculated based on the following table:

iii. Products in the **“Purchase Level Builders”** segment include (purchases count towards total dollars but are not rebatable products):

7. Rebate Calculations:

- Retailers will submit Grower purchase/retailer sales information on behalf of the Grower for rebate payment calculation by October 31st, 2022.
- Rebates are paid on net sales purchase data as provided by the retailer(s).
- Rebates will be calculated based on 2022 Suggested Retail Price

- Rebate Payment:** FMC reserves the right to audit all sales of FMC products by the distributor / retailer to Growers in order to confirm the accuracy of the sales and to adjust if necessary, any affected rebates retroactively.
- Overpayment:** Any program overpayment will be refunded to FMC by the customer or will be deducted from future program payments at the election and discretion of FMC.
- Program Discrepancies:** Any claims for discrepancies in program payments must be received in writing by FMC by December 30, 2022.
- Grower Usage:** To qualify for the above rebates, eligible products must be used by the same Grower who purchased them, on a single farming operation.
- Retailer Qualifications:** All herbicide purchases must be made from an authorized crop protection retailer with CropLife Phase III facilities.
- Product Returns:** Growers will not receive rebates for products that are returned for any reason. It is the sole responsibility of the Grower to advise FMC if a return has occurred after the issuance of the Grower’s rebate cheque. Failure to do so constitutes fraud and renders the program rebate null and void and potentially could be subject to legal action.
- Additional Programming:** Participating Growers may be eligible for additional FMC programs or rebates. See Terms and Conditions of any other programs for program eligibility.
- Information and Data Usage:** Via pre-enrollment as indicated in section 3 or by enrolling in the 2022 Offer, the Grower acknowledges that their retailer(s) will submit purchase information, which may include

personally identifiable information such as contact information and all necessary purchase data from the Grower and the Retailer, on their behalf to FMC and authorizes FMC, their affiliates and any third parties designated by FMC to use such information provided for the following purposes:

- a. Calculation, administration and fulfillment of this program.
- b. As a basis to send information that is relevant and useful to the Grower or respond to Grower queries using any form of communication including telephone, fax, email, text message, instant message and social media to ensure we are fulfilling our customer centric core value
- c. To provide baseline data to improve the program in the future to further benefit the Grower
- d. To further enhance our current level of services and product offerings
- e. Other required purposes that require the Grower to consent to as permitted and required by law
 - i. Certain of these affiliates or third parties may be located in countries outside of Canada. If a Grower does not wish to receive product/offering information from FMC, the Grower can contact FMC at 1-833-362-7722. For more information on how FMC handles information, visit privacy.FMC.ca.
- f. If a Grower chooses to revoke their consent for usage of the data for any of the reasons stated in section 14 through expressed written notification, FMC reserves the right to terminate the Grower's participation in the 2022 Offer. This termination will result in the immediate forfeiture of any fiduciary entitlements that would otherwise be due to the Grower under the 2022 Offer or other FMC programs. This termination would also result in the immediate forfeiture of the free sign-up gifts outlined in section 4, specifically subsections "A" and "D"

16. **Minimum Cheque Rebate:** FMC reserves the right not to send a rebate cheque for less than \$100.00 in total rebate dollar value to the Grower. Grower must qualify and have purchases over \$5,000.00 to receive a rebate.

17. **Prior Notice:** FMC reserves the right to modify this program in its sole discretion. Program subject to change without notice.
