TERMS & CONDITIONS

1. **Offer Period:** The 2026 FMC CashBack (the "Offer") is administered by FMC of Canada Limited ("FMC") and begins on November 1, 2025 and concludes on October 31, 2026.
2. **Eligibility:** The Offer is open to Canadian Growers who reside in British Columbia, Alberta, Saskatchewan or Manitoba and are the owner, operator or designated representative of a farm.
3. **Pre-Enrollment:** Growers who participated in and received a rebate payment from FMC from the 2025 FMC CashBack program will automatically be enrolled for the 2026 Offer. This enrollment will remain in effect for all subsequent years unless FMC receives notification in written form from the Grower explicitly stating that they no longer wish to participate in the current or subsequent Offers.
4. **2026 Enrollment:** New Growers who meet the qualifying purchase criteria for the 2026 FMC CashBack Program will be asked to provide consent for FMC to receive purchase information at <https://ag.fmc.com/ca/en/cashbackform>.
5. **Qualification:** Purchase a minimum of \$5,000 of eligible FMC products between November 1, 2025 and October 31, 2026.
6. **Purchase Segments:** Rebates are paid as per the following logic:
 - (a) Total dollars purchased of FMC products at 2026 Suggested Retail Price (MSRP) pre-qualify a Grower for rebates corresponding to the segment of products and their total purchase percentages as per the chart below:

- (b) No minimum unit or acre purchase is required in any segment to receive a rebate on that segment.
- (c) No matching acres are required between the Biologicals, Pre-Herbicide and In-Crop Herbicide segments.
- (d) Purchases from the Purchase Level Builders Segment count towards the overall dollars purchased and can move the Grower up in the dollar categories, however, the products within this segment are not eligible for rebates.

There are 4 product segments (See below for products in each segment).

- i. Products in the "Biologicals" segment include (products eligible for rebate):
 - Optimize® FXC DS, TagTeam® and TagTeam® BioniQ®.
- ii. Products in the "Pre-Herbicides" segment include (products eligible for rebate):
 - Authority® 480 herbicide, Authority Strike™ herbicide, Authority® Supreme herbicide, Avireo™ herbicide, Command® 360 ME herbicide, Command® Charge herbicide, Focus® herbicide, Focus® NXT herbicide, Intruvix® herbicide, Intruvix® II herbicide, PrecisionPac® herbicides (SZ-75 herbicide, SZ-75-18 herbicide, SZ-100 herbicide, SZ-0050 herbicide, CF-09-878 herbicide, CF-18-878 herbicide, CF-18-439 herbicide, CF-18-50 herbicide, CF-18-878 PRO herbicide, PF-100-0050 herbicide).
- iii. Products in the "In-Crop Herbicides" segment include (products eligible for rebate):
 - Ally® Toss-N-Go® herbicide, Barricade® II herbicide, Barricade® III herbicide, Predicade® herbicide, Refine® M herbicide, Refine® SG herbicide, Travallas® herbicide, PrecisionPac® herbicides (PP-2525 herbicide, PP-23235 herbicide, PP-3317 herbicide, DB-8454 herbicide, DB-6654 herbicide, Ally® High herbicide, Ally® Low herbicide, CS-75-2525 herbicide, CS-100-2525 herbicide, CS-75-23235 herbicide, CS-100-23235 herbicide, CS-100-50 herbicide, CS-75-50 herbicide, Perimeter® II herbicide).
 - Perimeter® II herbicide must always be matched to total acres of PrecisionPac® In-Crop herbicide blend purchase.
 - Perimeter® II herbicide rebate dollars will be calculated based on the following table:

iv. Products in the “Purchase Level Builders” segment include (purchases count towards total dollars but are not rebate eligible products):

- Aim® EC herbicide, Avoda® PRO seed treatment fungicide, Express® SG herbicide, Express® PRO herbicide, Express® FT herbicide, Express® FX herbicide, Express® LW herbicide, PrecisionPac® herbicides (CF-09, CF-14, CF-18, NC-0050, NC-00439, DB-878 and DB-878 PRO), Beleaf® 50SG insecticide, Carbine® insecticide, Coragen® insecticide, Coragen® MaX insecticide, Cygon® 400 insecticide, Cygon® 480-AG insecticide, Exirel® insecticide, Pounce® 384EC insecticide, Muster® herbicide, Muster® Toss-N-Go® herbicide, Pinnacle® SG herbicide, Pinnacle® SG Toss-N-Go® herbicide, Sulfentra herbicide, UpBeet® herbicide, BioniQ®, QuickRoots®, Cell-Tech®, JumpStart®, Nitragin Gold®.

7. Proactive Bonus:

- a. Growers are eligible for a \$1.00 per acre rebate when products from the In-Crop Herbicides category are matched to products from the “Pre-Herbicides” category.
- b. Products eligible for matching are listed above in the “Pre-Herbicides” and “In-Crop Herbicides” categories.
- c. Acres used to calculate this bonus will be based on the chart at the bottom of the Terms and Conditions.
- d. Growers cannot match the same acre to multiple products purchased as noted in the examples below.

For example:

1. Grower purchases 800 acres of Authority® 480 herbicide, 600 acres of Focus® herbicide, and 800 acres of Barricade® II herbicide.
 - a. This Grower will receive the matching \$1.00/acre rebate on the 800 acres that match between Authority® 480 herbicide and Barricade® III herbicide and will not receive a matching acre rebate on the 600 acres of Focus® herbicide.
 - e. In the event a Grower purchases more In-Crop Herbicide acres than one of their Pre-Herbicide purchases, but has additional purchases of Pre-Herbicides, the Grower will be eligible to match the remaining acres.

For example:

1. Grower purchases 1200 acres of Travallas® herbicide, 500 acres of Command® Charge herbicide and 900 acres of Intruvix® II herbicide.
 - a. The Grower will receive a matching \$1.00/acre rebate on the 500 acres of Command® Charge herbicide and then receive a \$1.00/acre rebate on the 700 acres of Intruvix® II herbicide. The remaining 200 acres of Intruvix® II herbicide cannot be matched as all 1200 acres of Travallas® herbicide have been matched.

8. Rebate Calculations:

- a. Retailers will submit Grower purchase/retailer sales information to AgData on behalf of the Grower for rebate payment calculation throughout the program year but no later than November 7th, 2026.
- b. Rebates are paid on net sales purchase data as provided by the retailer(s).
- c. Rebates will be calculated based on 2026 Suggested Retail Price. FMC reserves the right to change suggested retail price at any time during the season in its sole discretion which may impact the Growers' rebates within the Offer.
- d. Rebates amounts will be calculated and paid in Canadian Dollars.

9. Rebate Payment: FMC reserves the right to audit all sales of FMC products by the distributor/retailer to Growers in order to confirm the accuracy of the sales and to adjust, if necessary, any affected rebates retroactively.

10. Overpayment: Any program overpayment will be refunded to FMC by the customer or will be deducted from future program payments at the election and discretion of FMC.

11. Program Discrepancies: Any claims for discrepancies in program payments must be received in writing by FMC by January 31, 2026.

12. Grower Usage: To qualify for the above rebates, eligible products must be used by the same Grower who purchased them, on a single farming operation.

13. Retailer Qualifications: All herbicide purchases must be made from an authorized crop protection retailer with CropLife Phase III facilities.

14. Product Returns: Growers will not receive rebates for products that are returned for any reason. It is the sole responsibility of the Grower to advise FMC if a return has occurred after the issuance of the Grower's rebate cheque. Failure to do so constitutes fraud and renders the program rebate null and void and potentially could be subject to legal action.

- 15. Additional Programming:** Participating Growers may be eligible for additional 2026 FMC programs or rebates. See Terms and Conditions of any other programs for program eligibility.
- 16. Information and Data Usage:** Via pre-enrollment as indicated in Section 3 or by enrolling in the 2026 Offer, the Grower acknowledges that their retailer(s) will submit purchase information, which may include personally identifiable information such as contact information and all necessary purchase data from the Grower and the Retailer, on their behalf to FMC and authorizes FMC, their affiliates and any third parties designated by FMC to use such information provided for the following purposes:
- a. Calculation, administration, and fulfillment of this program
 - b. As a basis to send information that is relevant and useful to the Grower or respond to Grower queries using any form of communication including telephone, fax, email, text message, instant message, and social media to ensure we are fulfilling our customer centric core value
 - c. To provide baseline data to improve the program in the future, to further benefit the Grower
 - d. To further enhance our current level of services and product offerings
 - e. Other required purposes that require the Grower to consent to as permitted and required by law
 - i. Certain of these affiliates or third parties may be located in countries outside of Canada. If a Grower does not wish to receive product/offering information from FMC, the Grower can contact FMC at 1-833-362-7722. For more information on how FMC handles information, visit privacy.FMC.ca
 - f. If a Grower chooses to revoke their consent for usage of the data for any of the reasons stated in Section 16 through expressed written notification, FMC reserves the right to terminate the Grower's participation in the 2026 Offer. This termination will result in the immediate forfeiture of any fiduciary entitlements that would otherwise be due to the Grower under the 2026 Offer or other FMC programs.
- 17. Minimum Cheque Rebate:** FMC reserves the right not to send a rebate cheque for less than \$100.00 in total rebate dollar value to the Grower. Grower must qualify and have purchases over \$5,000.00 to receive a rebate.
