Petra can be applied at 5-10 Lit/Hectare in Soil Application.

In case of Phosphorus deficiencies, Petra can be used at 2.5 Lit/Hectare in Foliar application.

Petra is suitably formulated for drip application also at 2.5-5 Lit/Hectare.

The Soil application followed by Foliar application is recommended in majority of crops at appropriate growth stages.

**Directions for Use:**

Mixing **Petra** with irrigation water for field storage is generally not recommended.

Shake the container well before opening and use. Spray equipment should be clean if applied in foliar application.

**Compatibility:**

Please contact Local FMC representative for compatibility and crop specific dosages. Do not mix with conventional calcium based fertilizers.
