GENERAL INFORMATION:

Cadusafos - the active ingredient of Rugby 100 ME is a broadspectrum nematicide belonging to the group of organophosphates. Rugby 100 ME effectively controls a wide range of plant parasitic nematodes and especially the root knot nematode (Meloidogyne spp) on a variety of ornamental and other crops. Rugby 100 ME controls all nematode stages (Nematode eggs, Nematode larvae) providing complete root protection. A protection of the crop plants is achieved after soil application mainly by the contact action of the active ingredient against nematodes and also by ingestion. Rugby has no systemic activity. Moist soil or irrigation is required to activate Rugby 100 ME. Rugby has medium to low solubility in water and when it is applied to the soil, the active ingredient (Cadusafos) moves slowly and is diffused with the help of the irrigation water to the soil where it is attracted and absorbed by the soil colloids near the root zone. The nematicidal activity of Rugby 100 ME can last for 3 - 4 months depending on soil type.

Pre-harvest interval (PHI): 3 days Re-entry period: 12 hours

DIRECTIONS FOR USE

Use only as directed.

ORNAMENTALS

Application recommendation

Rugby can be applied at the establishment of the plants in the field (new plantings pre-transplant) or during the life cycle (established plants)

Application rate: 30 litres of Rugby 100 ME per hectare.

Method of application: Rugby 100 ME should be applied through a drip/trickle irrigation system.

New planting - pre transplant:

If soil is dry, irrigate 1 or 2 days prior to the application of Rugby. Drip irrigate 1 hour before Rugby application. Apply Rugby for 15-30 minutes. Continue irrigation for 1 hour on sandy soils or for 2- 3 hours on medium-heavy soils. Proceed to transplanting or seeding 7-15 days after application of Rugby. Continue with normal irrigation regime.

Established plants:

Start irrigation for 10 - 15 minutes.

Apply Rugby utilising regular water quantities:

- 15 minutes on sandy soils,
- 30 minutes on heavier soils and hot weather,
- 30 minutes on medium soils and warm weather,

• 45 - 60 minutes on medium soils and hot weather. Continue with normal irrigation regime as required by crop.

TOLERANCE:

Rugby 100 ME is selective to most commonly used ornamentals. However, as some ornamental species and varieties may differ in their sensitivity to chemical, tolerance test should be carried out with Rugby 100 ME on a small scale before a large-scale application is undertaken. Observe for 48 hours for any signs of phytotoxicity.

USE LIMITATION

- Do not apply Rugby 100 ME on poorly grown or water stressed plants.
- Do not apply at high temperatures.

Note: Continual use of soil-applied products in certain soils may lead to an increase in the rate of bio-degradation of the active ingredient resulting in their reduced activity. If unacceptable control occurs with Rugby 100 ME, contact your Juanco SPS LTD representative for further information/advice.

HAZARDS AND PRECAUTIONS:

Highly toxic if inhaled

Moderately toxic if swallowed or absorbed through skin. Mildly irritating to the eyes.

Avoid contact with eyes or skin.

Do not breathe vapour.

Wear full protective clothing when handling the undiluted product: rubber apron over long-sleeved overall, gloves, boots, respirator, when applying - overall, gloves, face shield, boots. Do not eat, drink or smoke when using the product. Wash hands with soap and water before breaks and after work. Remove contaminated clothing immediately, wash separately with water and soap before re-use. Wash outside of gloves with soap and water prior to removal.

Take a shower at the end of work. In case of accident or if you feel unwell, seek medical advice immediately.

FIRST AID MEASURES

Eyes: Flush with water for at least 15 minutes. If irritation occurs and persists, obtain medical attention.

Skin: Wash with plenty of water and soap

Inhalation: Remove to fresh air. If breathing difficulty or discomfort occurs and persists, seek medical advice. If breathing has stopped, give artificial respiration and see a doctor immediately.

If swallowed: Drink 1 or 2 glasses of water and induce vomiting by touching the back of the throat with a finger or by giving syrup of IPECAC. Never induce vomiting or give anything by mouth to an unconscious person.

NOTE TO THE DOCTOR

Rugby 100 ME contains cadusafos, organophosphate - cholinesterase inhibitor.

Signs and symptoms of poisoning:

Symptoms of overexposure include headache, light-headedness, weakness, abdominal cramps, nausea, excessive salivation, perspiration, blurred vision, tearing, pin-point pupils, convulsions, tremor and coma.

Antidote: Atropine sulphate.

TREATMENT:

Basic aid, decontamination, symptomatic treatment, administration of antidote.

Start treatment by giving 2 mg atropine sulphate intravenously or intramuscularly if necessary, and repeat with 0.4 - 2.0 mg atropine at 15 minutes interval until full atropinization occurs (tachycardia, flushed skin, dry mouth, mydriasis).

Start 2 - PAM ("Protopam", "Ayerst") at the same time, following manufacturer's recommended dosages and administration. Contraindications: Morphine, barbiturates, reserpine, phenothiazines, theophylline.

HANDLING AND STORAGE:

Store under lock and key, so that only authorized persons have

Store in tightly closed original container in a cool, dry, wellven-

Keep away from food, drink, and animal feeding stuffs. Do not use or store near heat, flame or hot surfaces. Do not contaminate other pesticides, fertilizers, water, food or feed by storage or disposal.

ENVIRONMENTAL HAZARDS:

Do not contaminate surface water, ditches with chemical or empty container. Drift or run off from treated areas may be hazardous to aquatic organisms in neighbouring areas.
