PRECAUTIONS

PERSONAL PROTECTION

DO NOT eat, drink or smoke while using. Wear protective clothing such as impervious gloves, waterproof hat, coat and trousers when using. Remove protective clothing and wash hands and face thoroughly before meals and after work. May be harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with the eyes.

STORAGE

Store in original container tightly closed and in a locked dry, cool, well ventilated area, away from foodstuffs. When stored appropriately this product should show no significant degradation for 2 years from the date of manufacture. SPILLS AND DISPOSAL

When dealing with spills wear personal protective clothing and equipment as described in the PERSONAL PROTECTION section. Sweep up spilled material, collect and store in properly labelled, sealed drums for safe disposal. Avoid creating dust. If spray mixture is spilled, contain and absorb in suitable inert absorbent material and collect in drums as above. Deal with all spillages immediately. GENERAL INFORMATION

Octave® is a DMI fungicide which may be applied as a spray treatment to Ornamentals and Stone fruit, as a dip treatment to Ornamentals and a drench treatment in Mushrooms.

RESISTANCE

Resistance to this and other DMI products could develop in some disease situations from repeated use. To minimise this risk use strictly in accordance with label instructions.

It is an offence to use this product on animals.

DIRECTIONS FOR USE

MIXING

Thoroughly premix the required amount with a little water to form a slurry. Add water whilst agitating. For spray treatments maintain agitation while mixing and applying. Also agitate thoroughly after a stoppage before recommencing spraying. Use immediately after mixing.

COMPATIBILITY

Octave® is compatible with most commonly used insecticides and fungicides. **DO NOT** mix with strongly alkaline materials such as Bordeaux mixture and lime sulphur.

RECOMMENDATIONS

The rates suggested for spray application are for high volume sprays to the point of run-off. For concentrate spraying adjust dilution rate accordingly.

Crop	Disease	Rate	Remarks
Mushrooms	Brown spot (Verticillium sp)	3 g/ square metre in 1 L of water as a drench treatment	Apply 7 - 9 days after casing. DO NOT apply within 10 days of picking.
Ornamentals	Colletotrichum sp Glomerella leaf spot, Monochaetia sp, Pestalotia sp, Powdery mildew	100 g/ 100 L in sufficient water to obtain thorough spray coverage. 100 g/ 100 L as a dip	Apply at first signs of infection and repeat at 14 day intervals. Immerse whole plants in dip treatment prior to shipping.
Stone fruit	Brown rot	25 g/ 100 L	Apply at pink and repeat at 7 - 10 day intervals until petal fall. Shorter intervals may be required in wet weather. Use in mixture with non-DMI fungicides and apply no more than three treatments per season.
