



# Bo-La<sup>®</sup>

A foliar source of boron and molybdenum formulated to optimize plant uptake.

#### EC FERTILISER (Ireland only)

#### UK FERTILISER (GB only)

A liquid mixture of micronutrients:

boron (B) (ethanolamine) and molybdenum (Mo) (sodium).

Boron (B) soluble in water: 11.0 % w/w (150 g/l)

Molybdenum (Mo) soluble in water: 0.55 % w/w (7.5 g/l)

Net content: 13.6 kg

To be used only where there is a recognised need. Do not exceed the appropriate dose rates.

#### FORMULATION

Bo-La is a high concentration micronutrient formulation containing boron and molybdenum fully soluble in water.

#### RATES OF USE

Marginal Deficiency and Autumn application: 1.0 l/ha in at least 200 litres of water

Moderate Deficiency: 2.0 l/ha in at least 200 litres of water

Severe Deficiency: Apply at 2.0 l/ha initially followed by further applications as required if symptoms should re-appear.

#### TIMING

Bo-La can be applied to crops whenever a boron deficiency is observed or expected, but after the 3 leaf stage, or when there is sufficient foliage present to absorb the spray.

It is recommended that soil and tissue analysis results are used whenever possible to guide micro and macronutrient applications to optimise crop nutrient status.

Do not apply this product in very bright sunlight or in temperatures above 25°C. If possible, spray in the evening or early morning for best results.

#### APPLICATION

**Shake the container well before opening and use.**

Spray equipment should be clean.

Half fill the spray tank with water, begin agitation and add the required quantity

of Bo-La. Rinse the container thoroughly, add the rinsings to the spray-tank, complete the filling and apply without delay. Maintain agitation throughout. Clean sprayer thoroughly after use.

#### COMPATIBILITY

Bo-La is physically and chemically compatible with a wide range of agrochemical products. Consult your supplier for the latest information.
