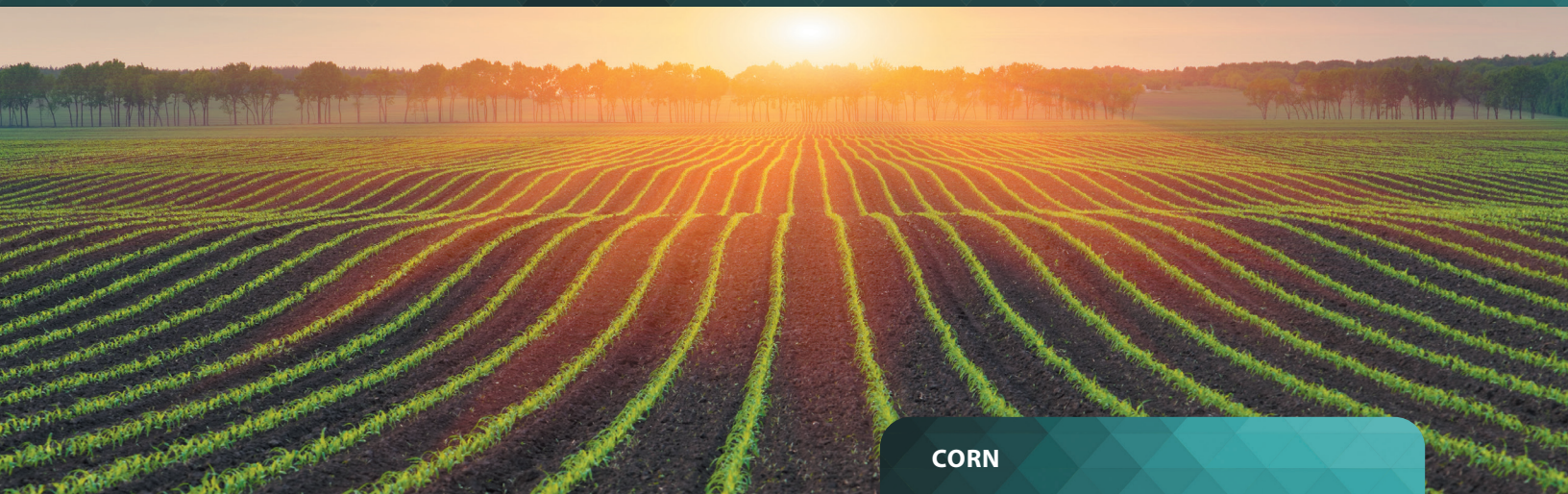

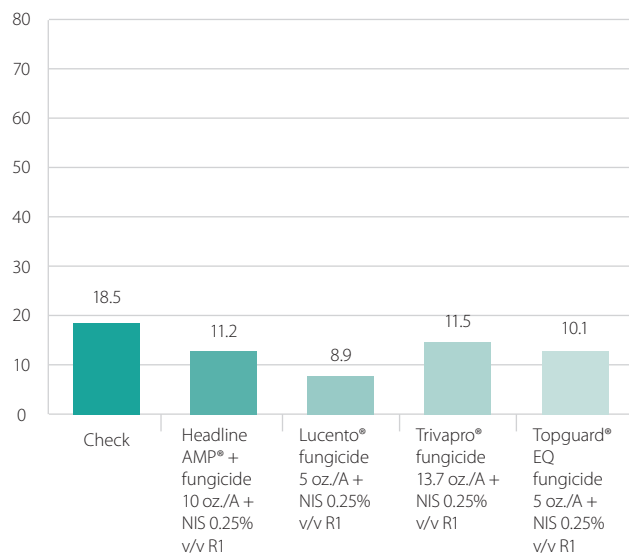

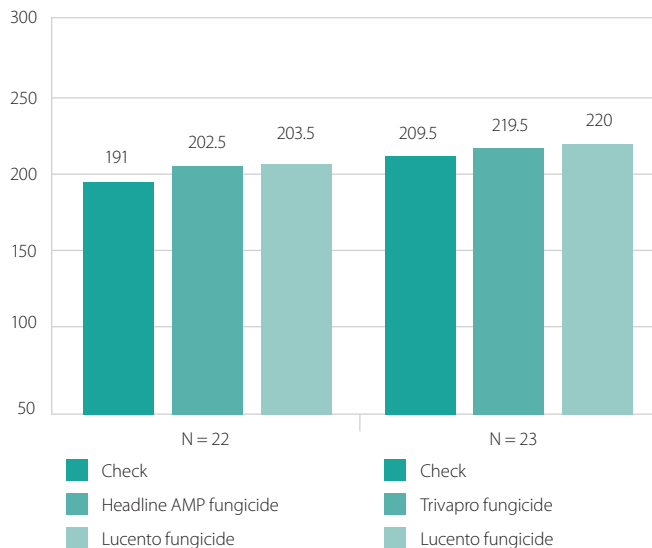

Trial Sites: NE, KS, IL – 3, KY, TN, PA

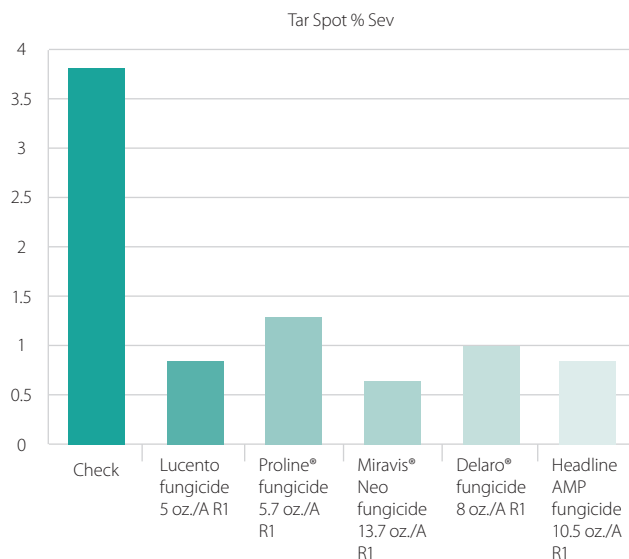
2017/2018 Multi-Site Corn Yield Data
