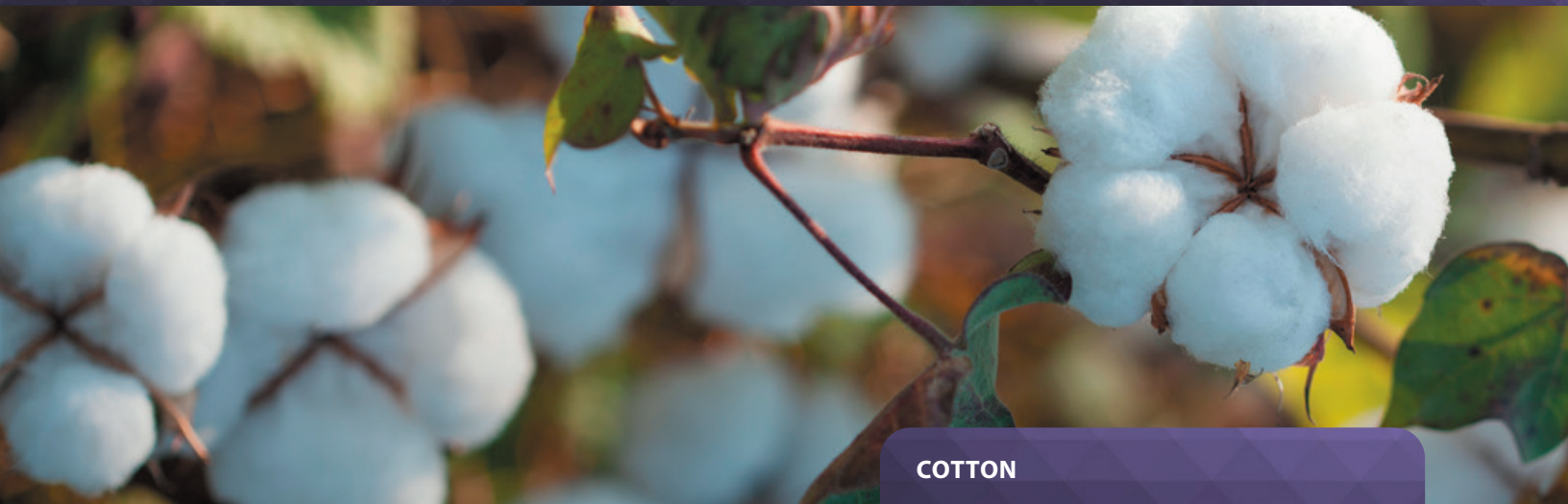

### Product Information:

Scouting for and identifying mid- to late-season cotton pests is an important step to manage boll damage and harvest quality. Since eggs and larvae are often found underneath the canopy, the level of insect pressure growers may be facing is deceiving. Brigade® 2EC insecticide/miticide provides excellent results controlling susceptible chewing, sucking and piercing pests that impact cotton.

Controlling these pests can help avoid substantial losses. Stink bugs, for example, can lead to economic losses from reduced yields and diminished fiber quality. The broad-spectrum active in Brigade 2EC insecticide/miticide reduces stink bugs, plant bugs, bollworms as well as mites. Plus, its all-weather chemistry reduces wash-off and increases residual activity for prolonged control. This insecticide/miticide can be applied via ground or air and is a flexible tank-mix partner with other insecticides such as acephate plus many other crop inputs.
