



2020 Corn & Soybean Replant Reimbursement Assurance

Program Description:

The FMC Corn and Soybean Replant Reimbursement Assurance program is designed to provide growers with additional protection from adverse weather and pest conditions when they use FMC brand products at-plant for their seed and seedling pest control in corn and soybeans.

Eligible Products	Reimbursement / Replant Coverage
Capture [®] LFR [®] insecticide	50% of the cost of additional treatment with an in-furrow brand used for replanting due to weather-related conditions.
Capture [®] 3RIVE 3D [®] insecticide	
Ethos [®] XB insecticide/fungicide

Replant Assurance – Growers are eligible through June 30, 2020, for reimbursement of **50% of the cost of an additional treatment** with in-furrow brands listed above should the grower choose to replant due to weather-related conditions. For this replant reimbursement, growers must apply the additional treatment in full accordance with all label directions.

To be eligible, growers choosing to participate must contact their local FMC retail market manager or Star Retailer before selecting the coverage option and making additional applications of any qualifying FMC product.

Program Requirements:

1. Grower must provide receipts for proof of replant.
2. Products must be applied according to label use directions.

Program Period: February 1, 2020 – June 1, 2020
Program Geography: Continental USA
Claim Submission Deadline: June 30, 2020
Program Payment Date: Approximately 30 days after claim resolution
