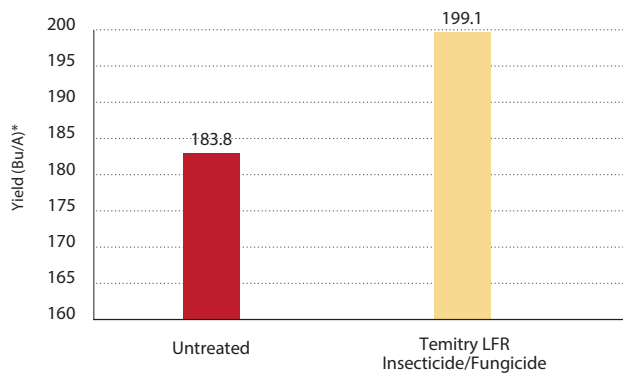

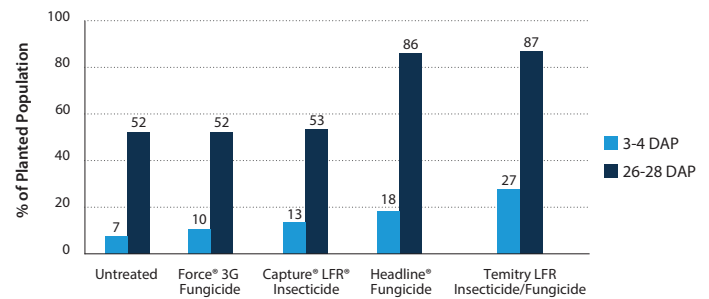
2015 Independent Research Trials



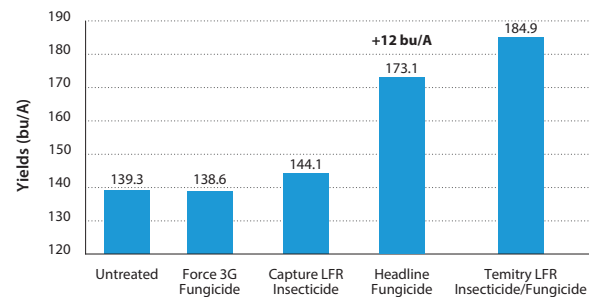
Corn rootworm protection impacts root ratings and increases yields. Temityr LFR Insecticide/Fungicide reduced rootworm feeding and increased yields over untreated checks by 15.3 bu/A.

Stand Count

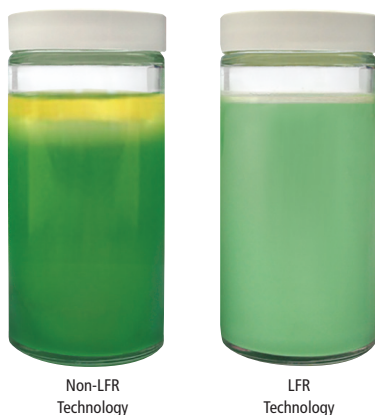


Yields



Temityr LFR Insecticide/Fungicide greatly increased both stand counts and final yields in field trials inoculated with *Rhizoctonia* and *Fusarium*. Stand counts improved from 52 percent to 87 percent, and the yield advantage was 45.6 bu/A compared to the untreated check. Notice the extra 12 bu/A compared to Headline fungicide alone. This demonstrates how the added insect protection of Temityr LFR Insecticide/Fungicide helps fend off disease by stopping insects from penetrating the plant and creating avenues for pathogens to invade the plant.
