FMC Freedom Pass Elevest[™] insect control Sweepstakes OFFICIAL RULES

Elevest insect control is a Restricted Use Pesticide and subject to grower purchasing requirements.

Short Rules: Ends August 31, 2021 at 11:59 pm ET. No Purchase Necessary. Void where prohibited. Must be age of majority in your state to enter. Open to legal residents of AL, AR, GA, LA, MS, MO, NC, SC, TN, & VA. Limit one (1) Sweepstakes entry per person. See official rules for details.

Use of Mobile Device: If you enter the Sweepstakes, post updates to or receive updates from a social media platform via SMS from your wireless phone, your entry may be subject to message and data charges for each message you send and receive. Please consult your wireless service provider for more information.

1. ELIGIBILITY: The FMC Freedom Pass Elevest[™] insect control Sweepstakes ("Sweepstakes") is open only to legal residents of Alabama, Arkansas, Georgia, Louisiana, Mississippi, Missouri, North Carolina, South Carolina, Tennessee, and Virginia who are the age of majority or older in their state or jurisdiction of residence at the time of entry. Employees, officers and directors of FMC Corporation ("Sponsor"), Deere & Company, John Deere Financial, and their respective parent entities, affiliates, subsidiaries, advertising and promotion agencies, and prize suppliers involved in this promotion and each of their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible to enter or win a prize. 11:59 p.m. ET on August 31, 2021 (the "Promotion Period"). Sponsor's computer is the official time-keeping device for this Sweepstakes. All Mail Entries must be postmarked by August 31, 2021 and received by September 15, 2021.

4. HOW TO ENTER: You are automatically entered by information provided in the transaction date report issued by John Deere Financial to FMC documenting the sale (for retailer prize) and purchase (for grower prize) of one or more gallons of Elevest[™] insect control and financing the purchase using FMC Freedom Pass financing through John Deere Financial. Or to enter by mail, sending a postcard containing your name, address and contact email or phone number to FMC Freedom Pass Elevest[™] insect control sweepstakes, Attn: USA Marketing Department-Floor 20, 2929 Walnut Street, Philadelphia, PA 19104. All Mail Entries are the non-returnable property of Sponsor. Proof of submission will not be deemed to be proof of receipt by Sponsor. Limit one (1) Sweepstakes entry per person.

Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different email addresses, identities, or any other methods may void that entrant's entries and that entrant may be disqualified from the Sweepstakes.
