



# 2021-2022 3RIVE 3D® Application System Program

## Program Description:

The 3RIVE 3D® application system is the fastest growing in-furrow application technology in corn and soybeans with additional crop opportunities on the near horizon. This program enables growers to choose the best option to access this technology for in-furrow crop protection from insects and diseases in registered crops.

### Option 1: Product Commitment Program

Growers who commit to and purchase minimum qualifying volumes of 3RIVE 3D brands in any combination listed in the table below qualify for a 3RIVE 3D application system at no initial cost. Growers can meet the total volume commitment at any time with a maximum of three years to meet the total volume commitment.

## Alternate Qualifying Products And Purchase Volumes To Meet Up To 30% Of Minimum Annual Purchase Volumes.

Purchase Ratio 1:1; For every one gallon of 3RIVE 3D brands, add one gallon of alternate brands in any combination. Purchase Ratio 1:2; For every one gallon of 3RIVE 3D brands, add two gallons of alternate brands in any combination.			
Growers choosing more than one product may achieve qualifying volumes using the product ratios indicated above. 1:1 ratio indicates equivalent gallons. 1.3:1 indicates that approximately 30% more product purchased – corrected to 15-gallon increments – is required to meet minimum qualifying volumes.			
No penalty for achieving volume commitments in less than three years. Growers may purchase any volume over the annual minimum requirement as long as the total volume commitment is achieved in not more than three years. If product purchase annual minimum is not met, grower agrees to pay the balance according to this formula: commitment gallons – purchased gallons x \$120/gallon

### Program Rules & Conditions:

1. FMC reserves the right to change any or all features of this program at any time.
2. Growers may choose either Option 1 or Option 2. Program options cannot be combined.
3. FMC reserves the right to audit all claims.
4. Misreported sales of any type are a clear violation of this program and will be subject to audit and possible forfeiture of all program benefits.
5. Program subject to 3RIVE 3D® application system availability.
6. Proof of product purchase from an FMC authorized distributor or retailer is required.
7. Purchases of qualifying products must be reported by July 1 of each program year until the volume commitment is met. Failure to report purchases will result in an invoice for one-third of the retail value of the application system per the table in Option Two above. Submit your Reporting Form and proof of purchase to FMC Corporation, Program Administration, P.O. Box 30757, Charlotte, NC 28230-0757.
8. Only FMC products specifically formulated for use in the 3RIVE 3D application system are eligible for this program. Any unauthorized products including other formulated chemistry, nutritional products and other additives used in the 3RIVE 3D application system will void any Product Assurance Programs and application system warranty. Grower assumes all risk.
9. To qualify, growers must complete, sign and submit the 3RIVE 3D Application System Grower Commitment Form to their local FMC representative no later than February 28, 2022.
10. Grower takes ownership of and title and risk of loss to the 3RIVE 3D application system upon delivery. Growers electing product commitment program options are obligated to purchase minimum volumes of qualifying products for each application system over a maximum three (3) year period to earn the total retail value of the 3RIVE 3D application system.
11. 3RIVE 3D application system will be delivered to the farm in a standard configuration to match the planter as specified on the 3RIVE 3D Application System Grower Commitment Form. Incomplete information may result in improper application system configuration.
12. Any non-standard parts and associated costs required to fit the application system to the planter are the responsibility of the grower and not included in this program.
13. Grower responsible for purchase and installation of desired in-furrow attachments such as Keetons, Rebounders, etc., for 3RIVE 3D product delivery.
14. Grower is responsible for installation or all installation costs if performed by a third party unless additional program participation requirements defined above are met.
15. This program does not constitute a service agreement. Grower is responsible for annual maintenance, non-warranty replacement parts, system upgrades and any other non-standard applicator equipment.
